#### Assist Director

- Need to figure out how we want to market ourselves to prospective students.
- Mikaela recommended pushing our on-campus activities.
- Recommended not doing Juke Bug, would rather do an interactive activity.
- Recommended to be next to student life.
- Shanara suggested creating a video showing everything we've been doing before Open Day and presenting it on a TV. Eric will ask if there's a TV we can use.
- High school student's there to look at courses instead of student life. Had a lot of prospective students asking where things are.
- Mikaela suggested having stickers for different degrees for us to wear.

## 9) Sports and Health Directors Update

- Eric said we can put in advertising for the Founders Cup in the Student Newsletter.
- Tharushi said that the schools haven't gotten back about getting players from schools.

#### 10) Marketing Director's Update

- Liz asked if we could start up a NDSA Tiktok, Taneisha thinks that's a good idea. General agreement from council. Very relevant.
- Have an old NDSA tiktok which can be revamped, just need to log in.

#### 11) Ordinary Council Member's Update

- Shanara will be stepping down from her position as health science representative but is working to get the Health Science Society up and running in the meantime.
- All club's receive \$500, additional \$250 grant for new clubs.
- All positions on the Multicultural society have been filled. In the process of organising Harmony Week. Collaborating with Welfare on the Tuesday for International Happiness



Day. Collaborating with Student Life on the Friday, as it will be the biggest day.

## 12) Vice-President's Update

- Understanding that it has been very stressful time and a lot of people are getting burnt out. Reaffirming that uni work is the number 1 priority.
- Following NDSA events, opening a feedback survey for students to fill out.
- At the start of a meeting filling out a positive sheet for someone in the committee.
- Pre-planning if we're going out after a meeting.
- Georgia informed council that if there's any feedback for the exec, go to Georgia and let her know.

#### Meeting with Selma

- Doing webinars with the schools where students can ask her questions as they don't usually have the chance to talk to higher up's.
- Wants to collect feedback on the temporary study space.
- Not enough space, no quiet spaces, lack of air-conditioning, charging ports don't work in drill hall.
- If there's any free classrooms you can go into them to study.
- There's a tutorial in one of the very few study spaces which seems really unfair.
- If the council has any conversations with people regarding it and people have any suggestions or comments, can feel free to message Georgia.
- Suggestion to put in tables in the courtyard by Drill Hall.

#### 13) Welfare Chair's Update

- Welfare is unable to fund another big event such as the World's Greatest Shave, discussion with Eric to have it be an NDSA/MSAND event.
- MSAND has been adamant that they have two med students on the committee.
- Would be able to get staff involved as well.
- MSAND isn't affiliated with the NDSA and they don't have a desire to be. They brought forward 3 options:
  - 1. They run it on their own.
  - 2. The NDSA runs it in collaboration with MSAND.
  - 3. The NDSA runs it on our own.
- They brought this forward to us as they wanted it to be university wide instead of just for medical students.
- MSAND has experience running it before. Discomfort regarding having the NDSA and the MSAND name on the same event. They have sent an email explaining how to run it
- Student Life would be more inclined to help out if it's just us and not MSAND.
- Welfare event but with the support of the rest of the NDSA.

#### Welfare Week:

Catered for 100 students but ran out within 10 minutes.



Concern with whether they've catered for enough students regarding coffee van. Eric stated that they'll take a lot longer to do coffee, it'll be fine.


